Dear Resident or Trader,

**Important update on Bounds Green CPZ for residents of Richmond Road and Eleanor Road.**

The proposed CPZ in Bounds Green has now been approved by the council's Cabinet. We are only waiting for the formal withdrawal of an objection from Enfield Council. We expect this to be resolved soon.

The feedback from the original consultation indicated that residents in Richmond Road and Eleanor Road did not want to be included in the CPZ. Therefore these roads are not included in the current plans. However, since the original consultation and subsequent publication of the revised CPZ area, we have received representations and petitions from Richmond Road residents asking for their road to be included to prevent any possible displacement parking into their road.

Eleanor Road is also very likely to be affected by displacement parking after the introduction of the CPZ.

**Therefore we are now proposing to include Richmond Road and Eleanor Road in the Bounds Green CPZ.**

Before we begin implementing the CPZ we want to give you, the residents of Richmond Road and Eleanor Road, another opportunity to give us feedback on this proposal. We are asking you again for your views as you are likely to experience displacement parking in your road.

## What are the current proposals?

The current proposals involve a scheme that would operate for a two hour period, Monday to Friday between 10am and 12noon on the following roads: Durnsford Road, Gordon Road, Passmore Gardens, Bounds Green Road (between the junction of Eastern Road to junction of Warwick Road), Warwick Road, Maidstone Road, Brownlow Road, Queens Road, Fletton Road, Herbert Road, Whittington Road, Thorold Road, Northbrook Road, Manor Road, Rhys Avenue, Corbett Grove, Eastern Road, Imperial Road, The Drive and Trinity Road.

## Next steps

### Statutory Consultation

This is the legal part of the process and takes the form of a public notice advertised in the local press, London Gazette and visible locations within the area to inform residents of the council's intentions.

The notice will be advertised on **28 June 2007** and provides a 21-day consultation period for interested parties to make representations regarding the council's intentions to implement parking controls.

This leaflet is part of the statutory consultation process which Haringey Council undertakes to make sure our residents are fully informed.

Please note that Statutory Consultation differs from informal consultation in that any interested party can make a representation, rather than restricting the consultation to a specified area. Any representation must also include reasoned comments as well as an agreement or objection.
